Bristol White Eagle Fencing Club recognises its responsibility for the safety of all its members, and to protect and safeguard the welfare of the children and young people entrusted to the club's care.

All children (i.e. those under the age of 18) regardless of age, disability, race, religious belief, and sexual identity have a right to be protected from abuse.

The welfare of children is everybody's responsibility particularly when it comes to protecting children from abuse. Everyone – administrators, coaches, parents, friends, children themselves can help and have a responsibility to keep children safe.

Disclosure and Barring Service (DBS)

As outlined by British Fencing it is club policy that any individual over the age of 16 who has regular contact with young people, for example coaching, referee, armourer, and volunteers, to be criminal records checked. This is undertaken by the Disclosure and Barring Services (DBS).

Photographic and Video Policy

Photography and videoing can play an important part in a fencer's journey whether it be memories of a first fencing kit, first tournament or for training purposes.

It is important to remember that no image can be taken of any child or young person without their consent and the consent of the parent or carer.

It may not be published without clear purpose of its intent and must not cause any embarrassment to the individual. Please make sure permission is sought by the individual and the coaches before any photography or videoing is taken i.e. within the sports hall, club competitions and camps.

The club [membership form](#) incorporates a tick box for opting out of any photography or videoing.

First Aid

Our coaches are First Aid qualified and have access to first aid kits.

All fencers must complete a membership form including the contact details of parents, carers, and In Case of Emergency numbers (ICE).

Club coaches must be informed of any medical conditions of young people at the club where appropriate.
